### FARM MARKET REGISTRATION

**What types of foods may the farm market offer for sale and still be exempt from the RFE license?**

A farm market that **only** offers for sale the following types of food items from the farm is exempt from the RFE license:

- fresh unprocessed fruits or vegetables
- maple syrup, sorghum, or honey [properly labeled]
- properly labeled products of a cottage food production operation
- cider and other juices *manufactured on site* at the farm market [properly labeled]
- raw eggs, raw poultry, and raw non-amenable meat on the condition that those products were produced by the farm market operator, and further conditioned that, with respect to the eggs offered from the location where the eggs are produced, the farm market operator annually maintains five hundred or fewer poultry, and with respect to the dressed poultry offered from the location where the poultry is raised, the farm market operator annually raises and slaughters one thousand or fewer poultry
- Commercially prepackaged food that is not potentially hazardous, on the condition that the food is contained in displays, the total space of which equals less than one hundred cubic feet on the premises where the person conducts business at the farm market
